## Parent/Legal Guardian Request for Proxy Access of a Minor

Memorial Hospital provides internet-based access to portions of a patient’s medical records through our patient portal, mHealth, which allows the patient or representative to view and manage information about their care.

Minors have the right under Nebraska state law to consent to some health care services without involvement of a parent or guardian. Thus, Memorial Hospital must ensure that information related to those services is not accessible to others, including a parent or legal guardian, via the patient portal. Memorial Hospital will only permit limited proxy access to the patient portal of minors age 13 years or older, with proxy access authorization from the patient. For parents/guardians of a minor age 12 or younger, any proxy access will automatically be discontinued when the minor reaches their thirteenth birthday.

### Requesting Proxy Access of a Minor Patient’s Portal

I am requesting proxy access to the portal account for the minor patient named below. I am the patient’s parent or legal guardian.

By requesting access to a minor patient’s portal account, you must be the patient’s parent or legal guardian, having authority to make healthcare decisions on their behalf. Full proxy access is granted for patients from 0 to 12 years old, automatically restricted\* between 13 and 18 years old, and in accordance with Nebraska law is terminated at 19 years old.
